Previous minutes

1. The minutes of 8 November 2022 were agreed, with an amendment made to item 6.

## Business Programme

2. The Bureau considered a programme of business for the weeks commencing 14, 21 and 28 November 2022.

## Approval of SSIs

4. The Bureau noted that motions to approve the following would be lodged—
  - Homeless Persons (Suspension of Referrals between Local Authorities) (Scotland) Order 2022 (SSI 2022/Draft)
  - Pavement Parking Prohibition (Exemption Orders Procedure) (Scotland) Regulations 2022 (SSI 2022/Draft).

## Referral and Timetabling of a Bill at Stage 2

5. The Bureau agreed to recommend to the Parliament that the Hunting with Dogs (Scotland) Bill be referred to the Rural Affairs, Islands and Natural Environment Committee for consideration at Stage 2. The Bureau also agreed to recommend to the Parliament that consideration of the Bill at Stage 2 be completed by 9 December.
6. The Bureau received an update on consideration of the Gender Recognition Reform (Scotland) Bill at Stage 2.
7. Alexander Burnett noted that extra time had been allocated to the consideration of the Hunting with Dogs (Scotland) Bill at Stage 2 while this had not been the case in relation to the Gender Recognition Reform (Scotland) Bill.
