We have been working to assess whether or not we have capacity to meet all the potential needs associated with the policy change (in particular assessing the budget implications for 2023/2024). At the current time we believe that our settings have (subject to being able to fill all vacant posts) the capacity to meet parental requests for deferred entry.

West Lothian

West Lothian Council formally updated its policy on funding an additional year of early learning and childcare on 22 November 2022 (copy report attached. West Lothian Council anticipated the introduction of the new legislation, and practice has been to grant access to funded ELC for those eligible to defer entry to P1 since August 2021, within the discretion allowed by the previous policy.
