Agenda item 2 – Minutes of previous meeting

Minutes of previous meeting agreed by Maggie Chapman MSP and Colin Smyth MSP.

Agenda item 3 - Change of Secretary

Change of Secretary agreed from Karen Coe to Lynda Holton.

Agenda item 4 – Presentation and talk: 'Seal disturbance as a growing problem: issues and solutions' by Dan Jarvis, Director of Welfare & Conservation, British Divers Marine Life Rescue

Key points raised during presentation:

- Issues include disturbance by air (drones and aircraft); sea (powered vessels and watersports including paddle sports); and land (proximity of people on land, noise and dogs e.g. dogs running into colonies). The problem is largely around lone seal pups e.g. anti-social behaviour such as pups being picked up by humans ('selfie' culture) or attacked by dogs. Some haulout sites in UK disturbed every 14 minutes.
- Impacts include disturbed rest (as seals need time on land), energetic loss, injury, maternal separation, miscarriage and even death.
- Solutions include in-situ methods (such as signs, leaflets, rangers, fencing); ex-situ (media releases, social media, public talks, code of conduct); policy and law (site protection, seal protection, enforcement). Marine (Scotland) Act 2010 and

Protection of Seals Order 2014 already exists for seals in Scotland but enforcement slow/limited. Video evidence is helpful but enforcement must be robust. Recommend: remote monitoring on all commercial fishing vessels and replicate efforts to add to Schedule 5 of Wildlife and Countryside Act 1981 (England).

Agenda item 6 - MSP Update

Colin Smyth MSP: Wildlife Management and Muirburn Bill now passed. Agriculture Bill Stage 2 – Colin proposing amendment re including animal welfare as an objective.

Maggie Chapman MSP: XL Bully issue ongoing. Been in touch with SSPCA Aberdeenshire re links between livestock farming and climate.

Emma Harper MSP: Dealing with local cases. Re livestock attacks – questions to FM and Minister Jim Fairlie. Has requested meeting with Cabinet Secretary.

Christine Grahame MSP: opposed XL Bully legislation due to concerns re definition; deed not breed best approach. Welfare of Dogs Bill Stage 1 debate expected 7th May. Registration scheme not supported by Scottish Government so will concede that part. However, still pursuing national microchipping database for dogs. Ban on glue traps in Wildlife Management and Muirburn Bill – Scottish Government left door open to enable exceptions in certain circumstances so not a complete ban.

Libby Anderson: UK Centre for Animal Law (A-LAW) online debate on 30th April about pet theft.

Helene Mauchlen: equine exhibition taking place in Parliament next week which will raise prospect of database for horses.

Gareth Hateley: shortage of people available to type animals.

Agenda item 8 - Next meeting

Date of next meeting agreed for early September (post-summer recess). Chair suggested trying it as an in-person meeting in Parliament. Agreed to try it as a hybrid meeting (part in-person, part online).
