Presentation by Lorna Cameron, Chief Executive Officer from Horizon Housing Association – Promoting accessible, inclusive homes for life.

Accessible and Inclusive Housing - why it is so important

- There is a chronic shortage of accessible housing in Scotland and as a direct result of being in an unsuitable house get injured
- Good design makes a possible difference
- Accessible housing is a human right, there is an equality issue at stake
- Passive housing has been addressed; it would be great if accessible housing was also addressed
- Making houses accessible makes them sustainable

We must acknowledge that accessible housing is a complicated issues that needs work from across sectors.

Q&A

- Lorna Cameron to Maggie Ellis confirmed to Maggie Ellis that Disability doesn't only include those with a physical disability but also includes a range cognitive, physical, neurodiverse, and sensory. Good networks to and Jeremy is speaking at a summit in September. Maggie mentioned Westminster only deals with England.
- Lorna Cameron to Linda Bamford wants to make sure they are sustainable as we work towards Net Zero and using energy efficiently and keeping bills to a minimum by draft proofing external walls, doors and windows insulation.
- Lorna Cameron to Pam Duncan-Glancy MSP future proofing housing, specifically on particular needs and targets/standards - there are many things that can be added to houses that are simple and less costly in the long run, such as flexible design & accessible spaces. It is all about small fixes and extensive consultation – it is better to do this than have to make adaptations at a later date.
- Lorna Cameron to Dr Caroline Gould agrees that the minimum 1.5m turning circle is too small. Is going to talk to agencies and organisations about this problem. Review of housing for varied need, as so many needs have

changed – Rurally it is sometimes difficult to get the specialised staff. At the summit discussions will include agencies and what will have more impact and what is needed to create a system that will work.

- Lorna Cameron to Denis Robert Shovlin - he wants Horizon to come to one of the Falkirk Council meetings to share their ideas, especially to represent non-physical disabilities, and will include Council housing and Local authorities. Lorna agrees with Denis, the more we can share the better.

Agenda item 4

Presentation by Debbie Horne – Independent Age – Scotland policy and public affairs Manager focused on recent report 'homing in' and the experiences of disabled people in relation to their housing and key point from report.

- Independent age is a charity for older people living in poverty, disabled people are among those who are more likely to live in poverty.
- 15% of older people who have a disability live in poverty
- 4/10 older private renters with a disability describe their financial situation as difficult
- Research found some 24,000 on Council waiting lists.
- Some people feel as though their only option is to render themselves homeless.
- Older private renters are twice as likely to think their home is unsuitable than older private renters without a disability.
- Only 36% of older tenants with a disability feel aware of their housing rights.
 - They also feel reluctant to assert their rights. Some fear that applying for adaptations could lead to eviction by landlords.
 - Half of older renters are not satisfied with the quality of their home and believe them substandard, (ie – home is never warm, damp, wind whistles in.
- Independent age recommends a framework of rent controls, and that the Scottish Parliament passes the Housing Bill and that the Scottish Government establishes a regulator for the PRS drawing on learnings from social housing regulator to drive up standards. To make older people with a disability aware of discretionary payments and how to access them.

Q&A

- Linda Bamford asks if there have been campaigning around the discretionary housing payments to help the older and disabled that there is support. Debbie Horne says there is a low uptake from older people for social security. Many

old people aren't aware of discretionary payments and how to access them or there is a stigma.. Low uptake of housing benefit.

Older people could access extra support but are sometimes unaware or are concerned about the stigma associated with it.
