S6M-13270 Mark Ruskell: Permanently Ending Peak Rail Fares on ScotRail—That the Parliament notes what it considers to be the success of the pilot scheme to remove peak rail fares, which has been in place since 2 October 2023 and has been further extended to the end of September 2024; believes that this has been an important tool in encouraging public transport use during the cost of living crisis, including for commuters in the Mid Scotland and Fife region; notes the belief that shifting commuters to low-carbon public transport is essential to drive down climate change emissions from the transport sector and contribute to the target of reducing car kilometres by 20% by 2030; further notes the support of the Scottish Trades Union Congress, and the rail unions RMT, ASLEF, TSSA and Unite, for the removal of peak time rail fares; notes the call to abolish peak time fares in the rail unions' joint report, *A Vision for Scotland's Railways*, published in October 2021, and further notes the calls on the Scottish Government to permanently abolish peak time rail fares.

*S6M-13523 Shona Robison: Scottish Elections (Representation and Reform) Bill: Financial Resolution—That the Parliament, for the purposes of any Act of the Scottish Parliament resulting from the Scottish Elections (Representation and Reform) Bill, agrees to any expenditure of a kind referred to in Rule 9.12.3A of the Parliament's Standing Orders arising in consequence of the Act.

Members' Business motions that have not achieved cross party support

*S6M-13505 Jamie Greene: West Coast Ferry Disruption and Replacement—That the Parliament notes with concern reports of a number of ongoing issues affecting CalMac ferry services on the west coast of Scotland ahead of the busy summer tourist season; further notes, in particular, reportedly ongoing problems with the MV Caledonian Isles, which were identified during its annual overhaul; understands that, as a result of the loss of the MV Caledonian Isles, the summer timetable for 2024 will be supported by two vessels rather than three as usual: further understands that this has led to a severe reduction in capacity for both passengers and vehicles on the route, as the MV Isle of Arran operates a core single vessel timetable on the Ardrossan-Brodick route; understands that damage to the Irish Berth at Ardrossan Harbour means that the MV Alfred can no longer operate out of Ardrossan, further reducing route capacity, and notes the calls on the berth's owner, Peel Ports, to work with North Ayrshire Council, CalMac, CMAL and the Scottish Government to resolve any ongoing disputes surrounding port maintenance; considers that the Ardrossan-Brodick ferry is the busiest ferry route in Scotland, carrying 692,518 passengers in 2022; emphasises what it considers to be the importance of the tourism industry to Arran's communities; notes the calls for all political parties to ensure that Ardrossan remains the principal port for the Arran route in the long term; understands that the MV Isle of Arran is 40 years old, whilst the MV Caledonian Isles is 31 years old; notes with concern the recently announced delays to the delivery of the Glen Sannox vessel to the route; understands that CalMac paid out £454,165 in 2022-23 in compensation to passengers for delays or cancellations, which was almost eight times the £57,822 paid out in 2017-18; further understands that, between 2017 and 2023, 6,302 sailings were cancelled due to technical issues; understands that the age and condition of CalMac's vessels has led to a deficiency of spare capacity and resilience across the network; notes the calls for adequate and timely investment to boost the resilience of the fleet, including the

commission of the small vessel replacement programme as soon as possible and a prompt resolution to the CHFS contract award that better meets the needs of island communities, and expresses sympathy with islanders who are affected most by disruption to sailings.

*S6M-13487 Marie McNair: Action Mesothelioma Day 2024—That the Parliament recognises Action Mesothelioma Day 2024, which is on 5 July 2024; understands that mesothelioma is a rare cancer that is usually caused by exposure to asbestos, with tiny fibres getting into the lungs and damaging them over time; notes that the cancer most commonly occurs in the lining of the lung. but can also occur in the lining of the abdomen and the lining of the heart, with symptoms including shortness of breath, chest pain, coughing and tiredness; understands that there are around 2,700 new mesothelioma cases in the UK every year, including around 200 in Scotland; recognises that Action Mesothelioma Day is a national event to raise awareness of asbestos and mesothelioma, raise vital funds to support the research into tackling mesothelioma, and to remember and support those who have been affected by the disease; notes with interest that a £2.1 million Cancer Research UK grant has been awarded to the University of Glasgow with the aim of answering the question of why it can take decades for exposure to the fibrous mineral to develop into cancer; applauds the long-standing and ongoing work of the Clydebank Asbestos Group, which has provided information and support to people with asbestos-related conditions for over 30 years; notes the calls for continued research into mesothelioma, and hopes for a successful Action Mesothelioma Day 2024.

*S6M-13469 Pam Duncan-Glancy: Saving the Trade Union Education Centre at City of Glasgow College—That the Parliament is concerned by proposals to close the Trade Union Education Centre at City of Glasgow College; understands that the Centre was formed in 1992, originally as part of Stow College in Glasgow and that, over the years, it has seen thousands of students enrol on its course; recognises what it sees as the vital role of trade union education in supporting workers' representation and rights; believes that, if it closes, a number of staff face losing their jobs; recognises what it sees as the important role the Centre has played in building the trade union voices of today and for the next generation of workers' representatives, and notes the calls for the threat of closure to be lifted.

*S6M-13499 Alexander Stewart: Alva Academy Heart Screening Event in Memory of Aiden Joyce from Tillicoultry—That the Parliament understands that a screening event has been held in memory of a Tillicoultry man who tragically passed away in 2023; understands that Aiden Joyce died on 7 March 2023, aged just 28, with his family discovering that he had an undiagnosed heart condition; considers that, in his memory, and to try and ensure that no other family experiences the same loss, his mother and father set up a heart screening session at Alva Academy over the weekend of 25-26 May 2024; notes that the family teamed up with charity Cardiac Risk in the Young (CRY) to bring this mobile heart screening station to Alva, and raised over £35,000 for the Aiden Joyce Memorial Fund, which will be used to screen young people aged 14 to 35; further notes that Aiden's mother, Lorraine, confirmed that 186 young people received life-saving heart screening tests, with around 12 referred for further treatment, and that she now aims to make the event an annual occurrence; sends its deepest sympathies to Aiden's parents, Lorraine and Campbell, and the family on their very sad loss, and commends everyone involved, as well as the generosity of local residents and businesses, for the event's enormous success.
