*S6M-13529 Jackson Carlaw: Success of Eaglesham Fair 2024—That the Parliament congratulates the Eaglesham Fair Organising Committee for putting together an outstanding range of activities for local people to enjoy at 2024's fair; understands that the Eaglesham Fair is a biennial event and aims to bring the local community together through the organisation of varied activities; recognises that a number of activities had been scheduled to celebrate this year's fair from 25 to 31 May, including the Eaglesham Fair Golf Competition, the Guided Eaglesham History Walk and a football match between Eaglesham and Busby Amateurs; acknowledges that the events to take place in the final week of May were followed by the main fair day on Saturday 1 June, which commenced with a procession at 11.15 am from Eaglesham Primary School, with the inclusion of walking groups and decorated floats; notes that the programme of events on the Saturday included Best Float Competition, performances from the Eaglesham Community Choir and the Mearns Castle Former Pupils Band, the Fair Dog Show, a Baking, Sewing and Novelty Competition and a Prizegiving Ceremony to present a range of awards; acknowledges that there was also a funfair with a range of attractions for local families to enjoy, such as the Royal British Legion Motorbikes, Classic Cars, Face Painting, Beat the Goalie and the Pop-up Play Village; recognises that activities for the 2024 fair concluded on Sunday 2 June with events at the Eaglesham Bowling Club and the Eaglesham Parish Church; understands that a large number of local organisations supported and sponsored activities at the fair, including Bonnyton Golf Club, Eaglesham Garage, Mearns Golf Academy, The Eglinton Arms and The Wishing Well; commends the Eaglesham Fair Organising Committee and all other groups and organisations involved with the 2024 fair for ensuring that it was both successful and memorable, and looks forward to further local community-centred events in future years.

*S6M-13528 Sandesh Gulhane: NHS Greater Glasgow and Clyde Warns of the Dangers of Button Batteries on Child Safety Week.—That the Parliament recognises that this Child Safety Week, which runs from 3 to 9 June 2024, NHS Greater Glasgow and Clyde paediatric surgeons are raising awareness of the danger to children of button batteries, particularly if swallowed; understands that lithium coin cell batteries can badly hurt or kill a child if swallowed and one becomes stuck in the gullet; notes that the Royal Hospital for Children is reporting increasing numbers of injuries as a result of children swallowing the batteries and, in certain cases, paediatric surgeons are dealing with serious complications; notes with concern that button batteries are being used in an increasing number of toys and other everyday objects in the home, such as remote controls and car keys, and considers that parents and carers should be aware that whilst the battery is secured away in most UK toys, this is not always the case with toys bought from abroad; recognises that preventing children from accessing the batteries could be lifesaving, and that batteries should be kept out of reach of children and locked away, and further recognises the advice that if a child has swallowed a battery then their parent or carer should take them to their nearest emergency department as soon as possible or call 999 immediately. R
