intervention, which has significantly improved patient mental wellbeing; understands that patients reported feeling calmer, more content and more in control of their lives, as a direct result of the art; notes that the exhibition connects patients, staff, family, friends and the wider public to raise awareness and change perceptions around people experiencing illness, and believes that it also allows visitors to the exhibitions to appreciate the work as the valid and vibrant art pieces that they are.

*S6M-15414 Marie McNair: Beyond the Virus Report on Integrating and Prioritising Mental Health and Wellbeing in Scotland's HIV Response—That the Parliament considers that there is an urgent need to integrate mental health within Scotland's HIV response, as highlighted by the recent HIV Outcomes UK report, Beyond the Virus: Prioritising mental health for people living with HIV in Scotland; acknowledges the report's findings that there are significant gaps in mental healthcare provision for people living with HIV in Scotland, and the barriers that this creates towards achieving the Scottish Government's 2030 goal to end new HIV transmissions; expresses concern regarding what the report refers to as the postcode lottery of mental health support, especially in rural and remote communities; commends the Scottish Government's vision in its Mental Health and Wellbeing Strategy of a Scotland that is free from stigma and inequality, where everyone fulfils their right to achieve the best mental health and wellbeing possible, and calls on the Scottish Government to implement the report's recommendations, including ensuring that HIV services across Scotland work to meet the British HIV Association Standards on psychological support for adults living with HIV, expanding HIV peer support services, and increasing training in healthcare settings to tackle HIV stigma, and further urges the Scottish Government to demonstrate the leadership and investment that it believes is necessary to ensure that all people living with HIV have consistent access to high-quality, stigma-free mental health support throughout Scotland.

*S6M-15378 Kevin Stewart: The UK Government's Approach to Energy Policy—That the Parliament notes the reported announcement from the APA Corporation that it will pull out of the North Sea in the next five years, with the firm stating that it will run a "very limited capital programme" in 2025 before ceasing all production in its North Sea assets by 31 December 2029; understands that the chief executive of APA Corporation, formerly known as Apache, has reportedly stated that this is well ahead of what would have been an otherwise reasonable time frame; notes that APA Corporation also reportedly states that "the onerous financial impact of the Energy Profits Levy makes production of hydrocarbons beyond the year 2029 uneconomic"; considers that this is further evidence that the UK Government's approach to energy policy is to blame for operators leaving the North Sea earlier than expected, which, it believes, will cause a loss of jobs and threaten the very investment needed for the transition to net zero, and calls on the UK Government to finally wake up to the situation that is unfolding in the North Sea and adopt a more realistic and practical approach, working with the industry instead of against it, before it is too late.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
