**[S6M-14431](#) Kate Forbes: Programme for Government – Growing Scotland's Green Economy**—That the Parliament recognises the actions outlined in the Programme for Government 2024-25 to grow the economy, eradicate child poverty, invest in Scotland's public services, and tackle the climate and nature emergencies; welcomes the publication of the Green Industrial Strategy to ensure that Scotland and its communities benefit economically from the global transition to net zero, including the creation of good, well-paid jobs; acknowledges the need to translate Scotland's strengths into competitive advantages in the global race; agrees that actions to promote investment, attract and develop a skilled workforce, support fair work and encourage innovation are essential for transforming Scotland's economy, and recognises that, by laying out concrete actions to accelerate the transition to net zero and position the green economy for long-term success, the Green Industrial Strategy will help build internationally competitive clusters in sectors such as onshore and offshore wind, carbon capture and storage, and green professional services.

### Members' Business motions that have not achieved cross party support

**\*[S6M-14427](#) Jeremy Balfour: Reversal of £10 Million Funding for Changing Places Toilets**—That the Parliament expresses its shock that the Scottish Government has, it understands, gone back on its pledge to invest £10 million to increase the number of Changing Places toilets across Scotland; notes that this promise was made originally in 2021 by the former First Minister as part of the 2021-22 Programme for Government, and was repeated numerous times by multiple ministers over the following years; understands that Changing Places toilets are not a luxury facility, but are vital for many profoundly disabled people to take part in society, including those in the Lothian region; considers that this is the latest in a long list of examples of the Scottish Government not taking seriously the needs of disabled people and allowing them to pay the price of what it sees as Scottish National Party (SNP) financial mismanagement; echoes the disappointment that has been expressed by many individuals and organisations in response to the announcement, and notes the calls for the Scottish Government to honour the promise that it made to disabled people.

**\*[S6M-14421](#) Emma Roddick: Crisis Report, A Window of Opportunity**—That the Parliament welcomes the publication of the Crisis report, *A Window of Opportunity*, which examines people's routes into homelessness in Scotland; notes with concern that the report concludes that "opportunities for public services to provide support to help people keep their homes are being repeatedly missed"; understands that the main findings of the report include an indication that people who become homeless are in touch with public services in the six-month period before a formal homeless application is made, that there are a number of interlinked factors that contribute to and prevent homelessness, and that many people who have experienced homelessness will not be able to achieve housing stability unless they are given ongoing support for unmet needs; notes that the report's recommendations include an ask of the Scottish Government to establish a

national communication strategy to educate the general public around the triggers for housing instability, and suggest that clear, measurable standards for cross-sector working to sustain homes are required; further notes the view that all of the findings and subsequent recommendations contained within the report demonstrate a requirement for the Scottish Government to prioritise preventing people from experiencing homelessness in the first place; recognises that the issues highlighted within the report will affect people who have experienced or are at risk of homelessness in the Highlands and Islands region; thanks Crisis for undertaking what it sees as this important research and for the production of an accessible document to accompany it, and notes the encouragement for the Scottish Government, in the context of the Programme for Government 2024-25 referring to the aspiration of the Housing (Scotland) Bill, to place "an emphasis on prevention through holistic support", and to reflect on how it can deliver on the recommendations contained within the report, with a view towards fewer people requiring access to homelessness services in the Highlands and Islands region, and across Scotland, in the future.

**\*[S6M-14444](#) Michelle Thomson: GLitter Team Cleans Up at Beautiful Scotland Awards 2024**—That the Parliament welcomes the success of Let's Get Grangemouth Clean, also known as the GLitter Team, at the Beautiful Scotland Awards 2024; notes that the group was successful in winning the Large Town Award and the New Entrant Award, which is presented to a first-time entrant that demonstrates endorsement and development of the Beautiful Scotland pillars; understands that the initiative started as a campaign in 2018 to remove excessive amounts of litter from the town and waterways, but has flourished to a team of volunteers who have, it understands, planted trees and plants and instilled a great sense of pride in the community; understands that the Beautiful Scotland Awards are organised by the environmental charity, Keep Scotland Beautiful, to celebrate the achievements of individuals and groups in enhancing their local areas; congratulates the GLitter Team on its achievements, and wishes it well in its future endeavours.

**\*[S6M-14443](#) Stephanie Callaghan: Celebrating Grow Uddingston's Success at the Beautiful Scotland Awards 2024**—That the Parliament welcomes the success of Grow Uddingston at the Beautiful Scotland Awards 2024; understands that Grow Uddingston won the best Urban Community Award, and the Jim Murdie Trophy for Sustainability, which is presented to the community entrant that demonstrates best practice in sustainability; notes that Grow Uddingston won this trophy due to its successful tree planting project, with over two thousand native woodlands saplings having been planted; considers that this has been an inspiring example of community tree activism and environmental practices, which have put sustainable approaches that will yield long-term benefits for wildlife, biodiversity and community at the forefront, and notes that the Beautiful Scotland Awards are organised by environmental charity, Keep Scotland Beautiful, to recognise the achievements and hard work of community groups across Scotland for all that they do to enhance and protect their local areas.
