***[S6M-14645](#) Christine Grahame: 25 Years of Tweeddale Youth Action**—That the Parliament congratulates Tweeddale Youth Action (TYA) on celebrating its 25th anniversary in 2024; notes that TYA, based in Peebles, provides a range of services to local young people, in addition to youth club drop-ins, excursions and holiday programmes, and also running the innovative Food Punks and Bike Punks initiatives; understands that Food Punks, a catering enterprise providing training to young people, has recently secured its first permanent premises on Peebles High Street, where it hopes to open a pizza shop, which will provide further hospitality training and employment opportunities for young people; further understands that Bike Punks also continues to go from strength to strength, with a workshop based in Innerleithen, tying in to the strong mountain biking presence in the area, which provides training on welding and repairing bicycles; believes that TYA has shown a genuinely innovative approach to improving the lives of local young people over its 25 years, which would not have been possible without the continuing hard work of the team of dedicated TYA staff, volunteers and trustees; wishes everyone involved the very best for the future, and recognises the contribution of youth work across Scotland in improving outcomes for young people.

***[S6M-14585](#) Keith Brown: Transparency of Political Donations in the UK**—That the Parliament notes the reported £4 million donation made to the UK Labour Party by Quadrature Capital, a company that, it understands, has significant investments in fossil fuels, arms

manufacturing and private healthcare firms, and which is owned by a firm registered in the Cayman Islands; understands that, according to Electoral Commission records, this donation was received in the one-week window between the announcement of the 2024 UK General Election and the start of the pre-poll reporting period, which requires all political donations over £11,180 to be published weekly, rather than the usual quarterly publication; further understands that this means that, despite being made on 28 May 2024, Quadrature's donation was made public by the Electoral Commission more than two months after Labour won the election; believes, with concern, that, as a result, this donation was able to avoid due scrutiny during the election period; highlights what it sees as the need for clear, transparent and timely reporting of all political donations to safeguard the trust of people in the democratic process, including those in the Clackmannanshire and Dunblane constituency; notes the calls for all political parties to adhere to the highest levels of transparency regarding donations, and further notes the calls for the UK Government to introduce stronger rules to improve transparency in relation to donations to political parties.

***[S6M-14663](#) Alexander Stewart: High-value Asda Foundation Grant Awarded to Kippen Village Hall**—That the Parliament welcomes the news that Kippen Village Hall, which is in the Mid Scotland and Fife region, has been awarded £15,815 by the Asda Foundation to help repair its floor and to refurbish facilities; notes that the hall is a community space that provides sports and leisure facilities for Kippen and its surrounding area; believes that the hall, which has facilities including a stage with a lighting rig, a meeting space, kitchens and toilets, offers free wi-fi and a small garden for outdoor activities, provides a safe and warm space for many community groups to use, including a playgroup and a mother and toddler group; notes that it also offers various fitness and sport sessions, a strength and balance class, a badminton club and yoga sessions and hosts regular community events, operates as a polling place and can be hired for private functions; acknowledges however that, although the building is registered with Stirling Council's Risk and Resilience Department for use in a local or national emergency, it has fallen into some disrepair; understands that this funding will be put toward its floor being repaired and deep cleaned and for the accessible toilet and baby changing facilities to be fully refurbished; notes that the award, which has been overseen by Keira Land, who is the Community Champion at Asda Alloa, is being delivered as part of the Investing in Spaces and Places fund, which will see 65 community groups across the UK receive a share of £1,225,782; understands that this is both the highest number of groups the fund has supported and the most money it has donated in a single year; believes that, since launching its Investing in Spaces and Places initiative in 2022, the Asda Foundation has pledged over £2.5 million to help transform community spaces; commends the company, its charitable arm and all of its community champions and staff on what it sees as this highly magnanimous and transformative community work, and sends its best wishes to all involved with Kippen Village Hall.

The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
