**\*[S6M-00647](#) Elena Whitham: Mauchline Primary Pupils Recreate Famous Burns Poem in CARS Project**—That the Parliament congratulates the excellent efforts of the primary six pupils at Mauchline Primary School, who recreated the famous Burns poem *Tae a Moose*, and also created a music video that tells the story of how Burns established his inspiration for writing the poem; commends the pupils on their outstanding work with the CARS Project, which aimed to create a programme of creative learning to contribute to the Mauchline Conservation Area Regeneration Scheme's strategic objective of commitment, engagement and participation with schools and the wider community to increase young people's understanding and appreciation of their own heritage and encourage a sense of pride in where they live and learn, and wishes the pupils well on entering their last year at primary school.

**\*[S6M-00645](#) Mercedes Villalba: Srebrenica Memorial Day 2021**—That the Parliament acknowledges that 11 July was the anniversary of the Srebrenica Genocide, which was marked by memorial events across the country, such as that organised by the Grampian Regional Equality Council, mosques and community organisations in the North East of Scotland; recognises that 8,372 men and boys were murdered in the town in eastern Bosnia-Herzegovina, and that the victims were predominantly Bosnian Muslims; understands that at the time of the conflict the Scottish Refugee Council helped evacuate 400 Bosnian refugees to Scotland; further acknowledges and affirms the importance of the 1951 UN Refugee Convention and 1967 Protocol, of which the core principle asserts that a refugee should not be returned to a country where they face serious threats to their life or freedom; believes that this must be reflected in the treatment of all those seeking asylum within the UK, and recognises the hugely valuable work done by Remembering Srebrenica to fight hatred and intolerance.

**\*[S6M-00639](#) Gillian Mackay: Motherwell Fans Raise Funds for Tickets for Unemployed People and Low-income Families—**That the Parliament congratulates Motherwell FC on the success of the Well In scheme, which provides free season tickets to unemployed people and low-income families in its local area; commends its supporters for raising £58,155 to date for this initiative; understands that, beyond the challenges of COVID-19, Motherwell and the surrounding areas also face economic issues in normal times, that the unemployment rate is higher than the Scottish and British average, and that many other families and individuals are surviving on low incomes, and notes that this scheme, alongside the Club 365 Summer Activity Programme delivered by Motherwell Football Club Community Trust, which delivers sporting activities as well as free school meals every day to all primary school pupils throughout the summer holidays, highlights the important role that this club plays in supporting families in need all across Lanarkshire.

**\*[S6M-00636](#) Sharon Dowey: Robyn Love Picked for Team GB—**That the Parliament commends the Ayr athlete, Robyn Love, on her selection for the ParalympicsGB wheelchair basketball team in the upcoming Paralympic Games in Tokyo this summer; understands that the games will be held between 24 August and 5 September 2021, having been delayed due to the COVID-19 pandemic; recognises the high level of achievement by the GB wheelchair basketball team, with the men's and women's teams ranked first and second in world respectively; notes that this is not Robyn's first visit to the games, having competed at the 2016 games less than three years after first taking up the sport; celebrates her previous achievements, including a silver medal in the Osaka championships in spring 2015, a European bronze in autumn 2015, a second European bronze in 2017 and the historic silver medal won by the GB squad in the 2019 European Championships, as well as a silver at the 2018 World Championships and helping the GB team secure its best ever performance to date in the Paralympics with fourth place at the 2016 games in Rio de Janeiro, and wishes Robyn and all the GB Paralympic team the very best at this year's games.

**\*[S6M-00631](#) Kenneth Gibson: Justice for Victims of the MH17 and their Loved Ones—**That the Parliament marks with sadness the seventh anniversary of the unprovoked shooting down of Malaysia Airlines flight MH17 by what it believes was a Russian army-owned Buk surface-to-air missile from a farm near Pervomaik, an area that was under control of pro-Russian forces, as it was travelling above Kursk from Amsterdam to Kuala Lumpur on 17 July 2014, resulting in 298 deaths, including 15 crew members and 80 children; applauds the efforts of the Joint Investigation Team, comprising of officials from the Dutch Public Prosecution Service and the Dutch police, along with police and criminal justice authorities from Australia, Belgium, Malaysia and Ukraine to establish the facts of the case, determine the truth of what happened, identify those responsible for downing flight MH17, and gather criminal evidence for prosecution; acknowledges that the District Court of The Hague has now concluded its first block of hearings on the merits in the MH17 criminal trial brought by the Dutch Public Prosecution Service against the four suspects, four Russian and one Ukrainian, which commenced on 7 June 2021, with proceedings scheduled to continue in the autumn; notes that the first hearing by the European Court of Human Rights of the inter-state application that the Netherlands submitted against the Russian Federation on 10 July 2020 for its role in the downing of Flight MH17, now joined with a Ukrainian application, will take place on 24 November 2021; continues to support not only the Dutch victims and families but

all 298 MH17 victims, of 17 different nationalities, and their loved ones; backs the Netherlands, the Joint Investigation Team and the Dutch Public Prosecution Service in its continued pursuit of truth, justice and accountability; urges the Russian Federation once again to accept responsibility for what it considers a heinous act of terrorism and to help secure justice for the victims and their families, and expresses Scotland's continuing sympathy to everyone whose lives have been impacted by what it considers this senseless act of mass murder.

**S6M-00606 Maggie Chapman: Environmental Justice for Torry Communities**—That the Parliament notes the proposals to re-zone two green belt areas in Torry, Aberdeen, the St Fittick's Community Park and Doonies Rare Breeds Farm, to facilitate port expansion as part of a larger industrialisation plan to create an energy transition zone (ETZ); recognises what it sees as the importance of transitioning away from fossil fuels, but also the negative impacts that over-industrialisation can have on resident communities, such as poor air quality, loss of green space and various forms of pollution, including noise; believes that community green spaces are positive for mental wellbeing and people's right to a healthy environment; appreciates the value of having an award-winning, biodiverse area of woodland, wetland and recreational grassland in these areas, which experience multiple social deprivation; acknowledges the opposition to the re-zoning by the community in Torry, including the Friends of St Fittick's campaign, on environmental justice and community wellbeing grounds; considers these sites to be valuable to the people and their rezoning to be inappropriate, and calls on Aberdeen City Council and the Harbour Board to work with the communities to find an alternative site for the ETZ, maximising the use of existing infrastructure wherever possible.

**\*S6M-00606.1 Mercedes Villalba: Environmental Justice for Torry Communities**—As an amendment to motion S6M-00606 in the name of Maggie Chapman (Environmental Justice for Torry Communities), leave out from "facilitate" to end and insert "provide land required for a port-centric energy transition zone (ETZ); recognises what it sees as the importance of transitioning away from fossil fuels, but also the negative impacts that over-industrialisation can have on resident communities, such as poor air quality, loss of green space and various forms of pollution, including noise; believes that community green spaces are positive for mental wellbeing and people's right to a healthy environment; appreciates the value of having an award-winning, biodiverse area of woodland, wetland and recreational grassland in these areas, which experience multiple social deprivation; acknowledges the opposition to the re-zoning by the community in Torry, including the Friends of St Fittick's Park campaign, on environmental justice and community wellbeing grounds; considers these sites to be valuable to the people and their rezoning to be inappropriate, and calls on Aberdeen City Council and the Harbour Board to work with the communities to find an alternative site for the ETZ, maximising the use of existing infrastructure wherever possible, and to urge the Scottish Government to make funding for an ETZ conditional on respecting the Just Transition Policy."
