***S6M-03627 Stuart McMillan: Inverclyde's Response to the Ukraine Crisis**—That the Parliament applauds Inverclyde's response to Russia's invasion of Ukraine, with Inverclyde Council donating £20,000 to the Ukraine humanitarian appeal; understands that businesses, youth groups, third sector organisations and community groups have also played their part in the local response, with Wildfire Deli in Gourrock, who initially organised a collection for items to be sent to Ukraine to help those fleeing the war, pledging to give all takings from 9 March 2022 to the Disasters Emergency Committee Ukraine appeal, resulting in a donation of £4,020, thanks to customers' additional donations; further understands that local Scout and Boys Brigade groups have also collected donations, and that volunteers from across the area have come together to help organise, pack and distribute essential goods to Ukraine after the Singh family opened the doors of the Cathcart House building, owned by their business, Alliance Group Management, to give volunteers a central sorting hub; understands that the Singh family also donated £3,000 to the appeal; further understands that The Gin Hotel in Greenock has offered to house Ukrainian refugees; commends everyone who has donated their time, money or items to the humanitarian appeal, condemns the actions of Vladimir Putin and the Russian Government in Ukraine, and hopes that peace in the region will be restored and democracy upheld.

***S6M-03626 Stuart McMillan: Clyde Muirshiel Regional Park's Efforts to Reduce Car Emissions**—That the Parliament congratulates Clyde Muirshiel Regional Park on receiving £15,760 from the Scottish Government's eBike Grant Fund, which is delivered by Energy Saving Trust; understands that this will allow Clyde Muirshiel Regional Park to purchase five eBikes and an eCargo bike to allow staff to commute to and from work and enable volunteers working with countryside rangers to cycle to areas of work with the ranger and transport hand tools to the site in the cargo bike; further understands that this will reduce vehicle use within the park by enabling staff to cycle between centres within Clyde Muirshiel and Gleniffer Braes parks, and that this reduction in vehicle use, it understands, should equate to around 40 to 70 miles per week of short journeys currently done by van; believes that this funding will help to deliver the transformational shift needed to help the country meet its 20% car kilometre reduction target, while also protecting the climate from what it sees as damaging transport emissions; commends Clyde Muirshiel Regional Park for the actions that it is taking to reduce its staff's impact on the planet, and wishes them all the best as they embark on this project.
