### Other new and altered motions and amendments

**\*[S6M-03911](#) Alexander Stewart: 40th Anniversary of the Falklands Conflict**—That the Parliament acknowledges that 2022 marks the 40th anniversary of the Falkland Islands conflict; considers that, on 2 April 1982, nationalist Argentine forces invaded and occupied the Falkland Islands, and that this resulted in a UK Task Force setting sail to recapture the Islands and restore freedom for the islanders three days later, on 5 April; understands that this involved 25,948 UK armed forces personnel, alongside around 3,000 civilian crew from the Merchant Navy, Royal Fleet Auxiliary and Chinese civilian crew, and that 255 died during the campaign, in addition to the tragic loss of three civilian Falkland Islanders; notes reports that, during the 74-day conflict between Argentina and the United Kingdom over two British dependent territories in the South Atlantic, the Falkland Islands and South Georgia and the South Sandwich Islands, more than 1,000 lives were lost; understands that this included 15 service personnel of the Arbroath-based 45 Commando and the 2nd Battalion of the Scots Guards; further understands that, following several weeks of intense fighting, Argentine forces surrendered on 14 June 1982, a date that has since been known in the Falkland Islands as Liberation Day, and is a national holiday there; acknowledges the reported statement from the Falkland Islands Government, that Falkland Islanders continue to be profoundly grateful for the strong support that the UK Government continues to provide, in acknowledging their choice to remain a UK Overseas Territory; considers that the people of the Falkland Islands continue to be forward-looking, with a strong sense of culture and heritage; commends what it sees as the immense bravery and fortitude shown by the Falkland Islanders and armed forces personnel amidst the harsh terrain and conditions during the conflict; understands that the Falkland Islands Government is calling this special commemorative year “Looking Forward at Forty”; believes that, across the UK, many events will be taking place between April and June 2022 involving the UK Armed Forces, as well as many charities and organisations, including ASA Forces Charity, Poppyscotland and the Royal British Legion Scotland, and is enthused that a Falklands War 40th Anniversary event is planned in Edinburgh on 18 June 2022. **R**

**\*[S6M-03896](#) Pam Duncan-Glancy: World Autism Acceptance Week 2022** —That the Parliament recognises this year's World Autism Acceptance Week, which takes place from 28

March to 3 April 2022, the aim of which is to draw attention to the reported 700,000 people living with autism in the UK; believes that people living with autism must be able to live in a world that respects their equality and human rights and becomes a much friendlier place for them; notes that the United Nation's theme for World Autism Acceptance Day 2022 is "Inclusion in the Workplace: Challenges and Opportunities in a Post-Pandemic World"; considers that far more needs to be done in Scotland to tackle the autism employment gap and support more autistic people into work; acknowledges the view that more needs to be done to educate employers on how to properly support autistic employees, and believes that political representatives should use their platform to advocate for autistic people's rights and wellbeing, not just this week, but every week.

**\*[S6M-03866](#) Bob Doris: Helping Young People Into University at The Maryhill Hub**—That the Parliament congratulates the University of Glasgow, along with joint partners, the University of Edinburgh and education charity IntoUniversity, on the launch of the new IntoUniversity centre in Maryhill, which is part of their commitment to widening access to education; understands that it will be based at the Maryhill Community Hub, in the area's Wyndford estate, it is the third Scottish centre to be opened in the last year, and will build on the success of the first two centres that launched in Govan and Craigmillar; commends the goals of this collaboration, which aims to connect young people, aged seven to 18, who may never have thought going to university was possible, with two of the world's leading Higher Education Institutions providing opportunities to support their learning and nurture their ambitions; understands that by working closely with local schools and other partners, including Glasgow City Council, the centre will provide ground-breaking support to young people, including after-school academic support, mentoring with university students and local professionals, in-school aspiration-raising workshops and enrichment, and work experience opportunities, and looks forward to the centre's contribution to the Widening Participation agenda.

**\*[S6M-03857](#) Pam Gosal: Luss and Arden Development Trust's Annual Community Clean-up**—That the Parliament applauds the efforts of Luss and Arden Development Trust, which saw a team of 36 volunteers turn out to pick up litter in the village and surrounding glens; understands that the area is a tourist hotspot and that the good weather brings in a large number of visitors, and acknowledges the support of the Lomond Arms Hotel and the Village Rest Café who provided refreshments for volunteers throughout the day.

**\*[S6M-03856](#) Michelle Thomson: The Polar Academy, Bo'ness**—That the Parliament wishes the team of intrepid explorers from Bo'ness Academy well on their expedition across the Arctic pole with Craig Mathieson's Polar Academy; understands that the team of ten pupils and one teacher left Bo'ness on 24 March 2022 on the first leg of their journey to Iceland, before leaving for Greenland to finally embark on their adventure across the Arctic; notes that the Polar Academy was founded by Craig Mathieson, explorer in residence at the Royal Scottish Geographical Society and committee member of The Explorers' Club Great Britain and Ireland Chapter, to inspire the next generation of leaders and explorers; understands that he uses his own experience of "inspiration through exploration" to do so; believes that the Polar Academy works with children and young people who have been the victims of bullying, abuse, and those lacking in self-esteem and confidence, and aims to help build them into leaders and role models, enabling them to inspire other young people to reach their full potential, and looks forward to seeing the team from Bo'ness

**\*[S6M-03855](#) Elena Whitham: Doon Academy Tackle Homophobia**—That the Parliament commends the pupils and teachers at Doon Academy, in Dalmellington, in setting up a football v homophobia event to tackle stigma in the game and in society as a whole; understands that the day was part of Doon Academy's progress towards its LGBT Youth Scotland Silver Charter award; notes that more than 120 people took part in the day by displaying rainbow colours as a sign of their ongoing efforts to change people's perceptions, and wishes them well in continuing on what it sees as this important journey.

**\*[S6M-03854](#) Elena Whitham: New Cumnock Development Trust**—That the Parliament congratulates New Cumnock Development Trust on successfully securing £24,750 in Scottish Land Fund funding; understands that the funding will be used to purchase the former Trotters building, a semi-derelict shop in New Cumnock, and turn it into a re-use and repair hub, which will help provide training and apprenticeship opportunities; commends the Development trust for all its hard work over the years, and wishes them well for the year ahead.

**\*[S6M-03851](#) Stuart McMillan: Gordon Miller retires after 26 years at Inverclyde Schools**—That the Parliament wishes popular janitor, Gordon Miller, from Gourock, a happy retirement after having clocked up 26 years at Inverclyde schools; notes that Gordon, 67, has spent the past 10 years at St Andrew's Primary and, prior to that, worked at St Gabriel's Primary, Slaemuir Primary, Greenock High School and Holy Cross Primary; understands that, before working in schools, Gordon worked for the MOD at Couport and was a chef by trade; recognises that St Andrew's P4/5 class made a special sign to spell out Happy Retirement and the school held an assembly where each class recited a poem or sang a song; believes that this shows how much Gordon will be missed by staff and pupils, and wishes him all the best for his retirement as he looks to spend more time with his family.

**\*[S6M-03850](#) Sharon Dowey: Supporting Hong Kongers in Scotland**—That the Parliament supports the welcoming of Hong Kongers to settle in Scotland; understands the need to make them feel welcome in the communities that they choose to settle in; further supports the setting out of a plan to attract more Hong Kongers to Scotland; acknowledges what it sees as the role this has to play in accommodating British National Overseas (BNO) visa holders who are fleeing Hong Kong; considers that there is a need to stop bullying and racism, which, it believes, some Hong Kongers face from some Chinese communities in Scotland; expresses its support to those who are applying to the BNO visa scheme in order to escape what it considers as the anti-democracy environment in their home city, and hopes that Hong Kongers are happy with their decision to settle in Scotland.

**\*[S6M-03847](#) Stuart McMillan: Inverclyde Libraries Benefit from Scottish Government**

**Funding**—That the Parliament welcomes the announcement that Inverclyde Libraries will benefit from £38,152 worth of funding from the last tranche of awards made from the Scottish Government's £1.25 million Public Library Covid Relief Fund, which is administered by the Scottish Library and Information Council; understands that Inverclyde Libraries will use this funding to tackle social isolation and bridge the digital divide through their Making It Real project, which offers a tailored digital inclusion outreach programme; notes that this programme targets residents within Inverclyde's most deprived communities who are, in turn, it believes, most disadvantaged by their lack of access to digital services; appreciates that the project also hopes to reconnect people to the wider library offer; commends Inverclyde Libraries on their efforts to tackle social and digital exclusion in the area, and wishes them all the best as they roll-out their Making It Real programme.

**\*[S6M-03846](#) Gillian Mackay: Knowetop Primary in Motherwell Becomes Silver Rights**

**Respecting School**—That the Parliament congratulates Knowetop Primary School, in Motherwell, on being granted the status of Silver Rights Respecting School by Unicef UK, following an assessment by one of Unicef UK's professional advisors who, it understands, looked at the whole school's rights respecting work; understands that this means Knowetop Primary has explicitly embedded the UN Convention on the Rights of the Child in its policy, practice and culture, and that children's rights in the school are learned, understood, and lived, and congratulates Knowetop's Primary 3 pupils on their work to tackle littering in and around the school by designing posters that ask people "to be clean, be green, and slam dunk the junk!"

**\*[S6M-03844](#) Gillian Mackay: South Lanarkshire College Supports Asylum Seekers to Learn English**

—That the Parliament commends South Lanarkshire College, in East Kilbride, for supporting a group of asylum seekers; understands that the nine students, all fleeing from Somalia, were looking for opportunities to train or study when the college stepped in to offer support; further understands that the students started their course on the 16 March 2022 and will be supported through a 12-week study course learning basic National 2 and 3 English, and wishes the students all the very best in their further education and for their future in Scotland.

**\*[S6M-03842](#) Stephanie Callaghan: Uddingston Pride - Keeping Uddingston an Attractive Place to Live and Work**

**\*S6M-03778 Fulton MacGregor: Research Highlights Need for Parental Co-operation Post-separation**—That the Parliament praises the research efforts of Mr Jamie Wark, who recently conducted innovative research on the views of young people in Scotland about the involvement of their parents while they were growing up; understands that the research had a particular focus on the views and experiences of young people whose parents separated at some point during their childhood; acknowledges the findings of Jamie's research that highlighted a lack of available support for the cohort of children of separated parents; notes that the research found that those who reached out to get support had a negative experience; understands that almost all contributors to the research stated that they would have liked to have seen the parent that they didn't live with more often; believes that this research underlines the need for parents to co-operate after separation to ensure that they act in the best interests of the child as well as helping children and young people with issues relating to the separation of their parents; praises Shared Parenting Scotland, which supported Jamie in conducting his research as a paid intern for the organisation, and further praises the Robertson Trust, which funded Jamie's placement as per its ethos of giving financial support and promoting career development amongst Scottish undergraduates.
