**[S6M-04799](#) Lorna Slater: Scotland's National Parks**—That the Parliament recognises the key role that national parks are playing in tackling the twin biodiversity and climate crises, and the important cultural, social and economic benefits that they bring to Scotland; welcomes the announcement by the Scottish Government that at least one new national park will be designated during the current parliamentary session; understands the need for an open and transparent evaluation process to identify the areas to be progressed to national park designation, and welcomes the start of stakeholder engagement to set the criteria for identifying the areas to be designated as new national parks.

**[S6M-04799.1](#) Brian Whittle: Scotland's National Parks**—As an amendment to motion [S6M-04799](#) in the name of Lorna Slater (Scotland's National Parks), insert at end “; notes the significant local support from communities involved in national park campaigns across Scotland, such as the Galloway National Park Association; acknowledges the concern expressed by many of these communities for what they feel is the unacceptably slow pace of the designation process; applauds the public demand for greater formal recognition of the value of Scotland's natural landscape and rural communities; believes that the interpretation of what constitutes a viable area for designation as a national park should be as broad as possible to ensure economic and environmental sustainability while recognising the diversity within Scotland's natural environment, and calls on the Scottish Government to explore other avenues to formally recognise and capitalise on Scotland's many outstanding areas of natural capital where national park status is not deemed appropriate.”

**[S6M-04799.2](#) Colin Smyth: Scotland's National Parks**—As an amendment to motion [S6M-04799](#) in the name of Lorna Slater (Scotland's National Parks), insert at end “; notes that there are over 3,500 national parks across the world; regrets that there have been just two national parks created in Scotland, the Loch Lomond and The Trossachs National Park, in 2002, and the Cairngorms National Park, in 2003, since the Parliament passed the National Parks (Scotland)

Act in 2000; praises the work of the Scottish Campaign for National Parks, which identified at least seven further potential sites in 2013, as well as community groups in Galloway and the Borders, and elsewhere, which continue to demonstrate clear demand for new national parks; recognises that, in addition to the designation of new national parks, it is vital that the national scenic areas and regional parks are reinvigorated to help tackle the climate, nature and biodiversity emergencies, and believes that the Scottish Government must pave the way for the opening of a number of new national parks across Scotland."

**[S6M-04013](#) Sue Webber: Economic Value of Medical Charity Research in Scotland**—That the Parliament notes the publication of two reports by the Fraser of Allander Institute and British Heart Foundation Scotland about the role of medical research charities in Scotland’s medical research environment; welcomes the findings regarding the economic impact of medical research charity funding in Scotland, which, it understands, supported 7,475 jobs, £470 million in output and £320 million in Gross Value Added (GVA) in 2019; understands that funding from medical research charities is amongst the most effective of all sectors, reportedly supporting £1.33 million in GVA and 31 jobs for every £1 million invested; notes what it sees as the significant impact COVID-19 had on the ability of medical research charities to fund research, putting, it understands from the research, 575 jobs, £36 million in output and £25 million in GVA at risk in 2020 alone; understands that the British Heart Foundation currently invests almost £33 million on research in the Lothian region, and notes the call from British Heart Foundation Scotland for continued support for clinical research infrastructure and research careers to ensure the long-term health of the medical research environment and to amplify what it sees as the benefit of investment into medical research to the economy.

SCOTTISH FOOD COMMISSION: CONSTITUTION AND OPERATION

**PART 1**

STATUS

*Incorporation*

1 The Commission is a body corporate.

*Exclusion of Crown status*

2 The Commission is not to be regarded as a servant or agent of the Crown, or having any status, immunity or privilege of the Crown, nor are its members or its staff to be regarded as civil servants.

*General powers*

**PART 2**

POWERS

3 The Commission may do anything which appears to it to be—

- (a) necessary or expedient for the purposes of, or in connection with, the exercise of its functions, or
- (b) otherwise conducive to the exercise of its functions.

### **PART 3**

#### PROCEDURE

##### *Committees and sub-committees*

- 4 The Commission may establish committees and sub-committees.

##### *Regulation of procedure*

- 5 The Commission may regulate its own procedure (including quorum) and that of its committees and sub-committees.

##### *Authority to perform functions*

- 6 The Commission may authorise any of its—

- (a) members,
- (b) committees,
- (c) sub-committees, or
- (d) staff,

to exercise such of its functions (and to such extent) as it may determine.

- 7 The giving of authority under paragraph 6 by the Commission does not—

- (a) affect the Commission's responsibility for the exercise of its functions, or
- (b) prevent the Commission from exercising the function itself.

##### *Validity of things done*

- 8 The validity of anything done by the Commission, its committees or sub-committees is not affected by—

- (a) a vacancy in its membership,
- (b) a defect in the appointment of a member,
- (c) the disqualification of a member after appointment.

### **PART 4**

#### ACCOUNTABILITY

##### *Corporate plan*

- 9 (1) The Commission must submit a corporate plan to the Scottish Ministers.
- (2) Sub-paragraph (1) must be complied with as soon as reasonably practicable after the day this paragraph comes into force.
- (3) The corporate plan must set out how the Commission intends to exercise its functions.

- (4) The corporate plan may include such other material as the Commission considers appropriate.
- (5) The Scottish Ministers must—
  - (a) approve the corporate plan,
  - (b) approve the corporate plan with any modifications they consider appropriate, or
  - (c) decline to approve the corporate plan.
- (6) Where the Scottish Ministers intend to approve the corporate plan with modifications, they must consult the Commission before doing so.
- (7) If sub-paragraph (5)(b) or (c) applies, the Commission must, as soon as reasonably practicable, modify the corporate plan and submit the modified plan to the Scottish Ministers.
- (8) Sub-paragraphs (5) to (7) apply to the corporate plan as modified.
- (9) As soon as reasonably practicable after it is approved by the Scottish Ministers—
  - (a) the Commission must publish the corporate plan, and
  - (b) the Scottish Ministers must lay a copy of the corporate plan before the Scottish Parliament.
- (10) The Commission—
  - (a) may revise the corporate plan at any time, and
  - (b) must revise the corporate plan when required to do so by the Scottish Ministers.
- (11) Sub-paragraphs (1) and (3) to (10) apply to a revised corporate plan as they apply to the first corporate plan.

#### *Accounts and audit*

- 10 (1) The Commission must—
  - (a) keep proper accounts and accounting records,
  - (b) prepare in respect of each financial year a statement of accounts, and
  - (c) send a copy of the statement to the Auditor General for Scotland for auditing.
- (2) The Commission must comply with any directions which the Scottish Ministers give it in relation to the matters mentioned in sub-paragraphs (1)(a) and (b).

#### *Annual report*

- 11 The Commission must, as soon as reasonably practicable after each financial year—
  - (a) prepare and make publicly available a report of its activities during the year,
  - (b) send a copy of the report to the Scottish Ministers, and
  - (c) lay a copy of the report before the Scottish Parliament.

#### **MEMBERS**

##### *Commission composition*

12 (1) The Commission is to consist of—

- (a) a member to chair it, and
- (b) at least 2 but no more than 4 other members.

(2) The Scottish Ministers may by regulations amend sub-paragraph (1)(b) so as to alter the maximum number of members.

14 (1) A person's membership of the Commission continues until the end of the period of appointment (subject to paragraph 16).

- (2) In sub-paragraph (1), "the period of appointment" means the period specified by the Scottish Ministers on appointing the person as a member.
- (3) The Scottish Ministers may determine other terms and conditions of membership, in relation to matters not covered by this schedule.

*Members' remuneration, allowances and pensions*

15 (1) The Scottish Ministers may—

- (a) pay members of the Commission remuneration and allowances (including expenses),



- (b) pay, or make arrangements for the payment of, pensions, allowances and gratuities to, or in respect of, any person who is or has been a member of the Commission.
- (2) The arrangements referred to in sub-paragraph (1)(b) may include—
  - (a) making payments towards the provision of those pensions, allowances and gratuities,
  - (b) providing and maintaining schemes for the payment of those pensions, allowances and gratuities.
- (3) The reference in sub-paragraph (1)(b) to pensions, allowances and gratuities includes pensions, allowances and gratuities by way of compensation for loss of office.

#### *Early termination of membership*

- 16 (1) A person's membership of the Commission ends if—
- (a) the person resigns by written notice given to the Scottish Ministers,
  - (b) the person becomes disqualified from being a member (see paragraph 17), or
  - (c) the Scottish Ministers give the person written notice that the person is removed from the Commission.
- (2) The Scottish Ministers may remove a member of the Commission by virtue of sub-paragraph (1)(c) only if they consider that the member is—
- (a) unfit to continue to be a member, or
  - (b) unable to exercise the member's functions.

#### *Disqualification from membership*

- 17 (1) A person is disqualified from being a member of the Commission if the person is—
- (a) disqualified from being a member by virtue of section 19 of the Ethical Standards in Public Life etc. (Scotland) Act 2000,
  - (b) disqualified from being the director of a company registered under the Companies Act 2006 in Great Britain.
- (2) The Scottish Ministers may by regulations modify this paragraph to add or remove descriptions of persons disqualified from being a member of the Commission.
- (3) Regulations under sub-paragraph (2) may not repeal sub-paragraph (1)(a).

#### *Appointment of staff*

- 18 The Commission may appoint staff.

#### *Staff terms and conditions*

- 19 Staff appointed by the Commission are appointed on such terms and conditions as the Scottish Ministers approve.

20 (1) The Commission may pay, or make arrangements for the payment of, pensions, allowances and gratuities to, or in respect of, any person who is or has been a member of its staff.

- (2) But the Commission may not make those payments or arrangements without the Scottish Ministers' approval.

- (a) making payments toward the provision of pensions, allowances and gratuities,

## Members' Bills Proposals

### Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
