**\*[S6M-04925](#) Pam Duncan-Glancy: Juvenile Idiopathic Arthritis (JIA) Awareness Week 2022**—That the Parliament acknowledges that the week commencing 13 June 2022 is the first Juvenile Idiopathic Arthritis (JIA) Awareness Week, run by the National Rheumatoid Arthritis Society (NRAS); recognises that the theme of the week is #SameJIADifferentDay, which emphasises the fluctuating nature of JIA that can vary from day to day; notes that JIA is an auto-immune condition where the body's immune system mistakenly attacks healthy joint tissue, leading to inflammation, stiffness, swelling, and chronic pain; further notes that JIA can also affect other organs, including the eyes; understands that approximately one child in every thousand under the age of 16 has JIA, which is approximately 925 children in Scotland; further understands that, due to the fluctuating nature of the condition, not all children are fully believed when describing their symptoms; recognises what it sees as the importance of the first JIA Awareness Week in raising awareness of JIA and eliminating misconceptions about it; pays tribute to the numerous organisations who work tirelessly to raise awareness of all arthritis conditions, such as the National Rheumatoid Arthritis Society (NRAS), Versus Arthritis, Scottish Network for Arthritis in Children (SNAC), and Scottish Paediatric and Adolescent Rheumatology Network (SPARN), and thanks them all for their excellent work and contributions in this field.

**\*[S6M-04790](#) Douglas Lumsden: Sir James Milne**—That the Parliament congratulates Sir James Milne, founder and chairman of the Balmoral Group, on receiving a knighthood in The Queen's Birthday Honours 2022; recognises his outstanding services to business and charity, in particular his drive to improve cancer care for patients; notes that Sir James founded the Balmoral Group, a highly-specialised manufacturing firm based in Aberdeen, in 1980; further notes that he jointly founded and serves as chairman of the Friends of ANCHOR charity, which supports Aberdeen's cancer and haematology care unit, as well as financing many ground-breaking research programmes; understands that, since the charity's creation 25 years ago, the Balmoral Group has covered all of the charity's administrative costs; further understands that the ANCHOR Centre, a state-of-the-art purpose-built haematology, oncology and radiotherapy facility, built in partnership with NHS Grampian at Aberdeen Royal Infirmary, will open to patients in September 2023; commends Sir James and Friends of ANCHOR for the work that they have done to improve cancer care; further commends Sir James for his other numerous contributions to business and charity, and congratulates him on his well-deserved knighthood.

Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
