**\*[S6M-05506](#) Craig Hoy: Protecting the Future of Scotland's Historic Environment**—That the Parliament understands that stonemasonry is vitally important for the protection and preservation of Scotland's historic environment and tourism, and that it can be hugely beneficial to young people from deprived backgrounds to start their career; commends the Ridge Charity in Dunbar, which it understands currently supports some of East Lothian's most marginalised community members to gain access to modern apprenticeships in stonemasonry and joinery; regrets the reported impending loss of stonemasonry apprenticeships at Edinburgh College and the impact that this may have on young people in the south of Scotland; notes the calls on the Scottish Government, Skills Development Scotland, Historic Environment Scotland and South of Scotland Enterprise to consider what it sees as the potential serious repercussions for the Ridge Charity and for the apprenticeship opportunities for young people in the south east of Scotland, and further notes the calls for stakeholders, including the Scottish Government, to engage to identify a positive solution for an accessible location that could be used for young people from Berwickshire, Edinburgh and East Lothian to gain access to stonemasonry apprenticeships through a satellite provision of an existing college provider.

**\*[S6M-05453](#) Clare Adamson: Gas Safety Week 2022, The Hidden Dangers**—That the Parliament marks Gas Safety Week 2022, which runs from 12 to 18 September and is coordinated by Gas Safe Register; understands that this is the 12th annual, pan-industry event, which brings everyone together for the common goal of keeping the nation gas safe while raising awareness of the dangers of poorly maintained gas appliances, which can cause gas leaks, fires, explosions and carbon monoxide poisoning; notes that Gas Safe Register provides a host of support and resources, including an interactive GasMap tool, allowing consumers to find out how many unsafe gas jobs have been carried out in their area, as well as providing helpful tips and reassurance; further notes what it sees as the need to raise awareness for those who live in rented accommodation, including holiday makers, that the law and regulations regarding gas safety are fully understood; commends the efforts of all of the organisations involved, and wishes those involved every success in raising awareness of an issue that could save lives. **R**

**\*S6M-05413 Jeremy Balfour: Stories of Hope: Addiction Recovery**—That the Parliament welcomes the new report published by the Evangelical Alliance and Serve Scotland, *Stories of Hope: Addiction Recovery*, highlighting what it sees as the extraordinary efforts that have been made by Christians in Scotland to assist and care for those in addiction and bringing to light the scope of Christian addiction recovery services across Scotland; notes the report's findings that over a quarter of Scotland's residential beds for addiction patients are offered by Christian groups; understands that over 2,300 individuals over the last decade have been directly supported to successfully recover from their addiction through services offered by Christian groups and churches across Scotland, including in the Lothian region, and notes the report's aim in encouraging greater joined-up partnership between the Scottish Government and Christian addiction recovery support charities to successfully tackle Scotland's drug deaths crisis.

**\*S6M-05292 Stephen Kerr: A Potato With More Vitamin C Than a Lemon**—That the Parliament believes that gene-editing technology is game-changing for food production; understands that there is a big difference between gene-modification and gene-editing; further understands that gene-editing makes small, specific changes to existing DNA, or removes a section altogether, speeding up a process that could occur through natural breeding; recognises that scientists at the James Hutton Institute in Dundee have reportedly predicted that gene-editing technology could result in potatoes with more vitamin C than lemons being grown, and considers that Scotland could be left behind England in food production due to Scottish legislation prohibiting the use of gene-editing in Scotland.

**\*S6M-05233 Katy Clark: Teachers' Pay**—That the Parliament notes that the Educational Institute for Scotland (EIS) union, which represents around 80% of teaching professionals, including in the West Scotland region, has launched its Pay Attention campaign, calling for a 10% pay rise for teachers amid the cost of living crisis; understands that the Scottish Negotiating Committee for Teachers (SNCT) Teachers' side has formally rejected the offer of 2% from the Employers' Side for 2022-23; considers that this pay offer is sub-inflationary in light of the Bank of England reporting an inflation rate of 9%; notes the views of the NASUWT Pay Claim booklet *Teachers' Pay Award 2021-22* that teachers' salaries have eroded in real terms in the last decade, and that, calculated using the Retail Price Index inflation factor, the real-terms fall in teachers' salaries from 2010 to 2018 was 18%; further notes that the EIS has reportedly stated that it will ballot members for industrial action if necessary; acknowledges what it sees as the extraordinary work of teachers during the COVID-19 pandemic, which included teaching young people both online and in person, often in what it considers to be poorly-ventilated classrooms, and notes the calls on the Scottish Government to take action to ensure all teachers and school staff receive a real terms pay rise for the year 2022-23.

**\*[S6M-05567](#) Edward Mountain: Lochinver Royal National Lifeboat Institution Raises £6,800 During Annual Gala Day**—That the Parliament commends Lochinver Royal National Lifeboat Institution (RNLI) for raising a record breaking £6,800 during its annual fundraising gala day, after a two-year absence because of the COVID-19 pandemic; notes that the event had support from local businesses and the community, which set up stalls to help raise money; notes the invaluable work that the RNLI crew provides, and wishes them luck in future fundraising events.

**\*[S6M-05566](#) Pauline McNeill: Huge Energy Company Profits Recorded**—That the Parliament is concerned that energy companies have reportedly posted record profits during the first half of 2022, despite the ongoing cost of living crisis; understands that Centrica, which owns British Gas, has reported operating profits of £1.3 billion, its highest in 10 years, and that Shell posted record results with an \$11.5 billion second-quarter profit, reportedly beating the huge profits it recorded only three months ago; further understands that the UK Government's "energy profits levy" did not come into force until July, and that such record profits and pay-outs to shareholders will therefore be unaffected; is further concerned about reports of a 77% rise in energy bills predicted to hit households in October, with a subsequent rise forecast in January 2023; understands that, by October, the average annual household bill will reach £3,500, and agrees with the financial journalist and broadcaster Martin Lewis's reported warning to the UK Government to urgently intervene on surging gas prices as they will have a "frankly catastrophic" impact on millions of people in the UK later this year.
