[S6M-05949](#) Mark Ruskell: Greyhound Racing in Scotland—That the Parliament notes reports that the last licensed greyhound racing track in Scotland, Shawfield Stadium, Rutherglen has not been operational since March 2020; further notes the Scottish Animal Welfare Commission's view that there should be an end to greyhound racing at unlicensed tracks, including, it understands, the last remaining track at Thornton in Fife; acknowledges reported animal welfare concerns linked with greyhound racing, including neglect, malnutrition, doping with Class A substances, lack of adequate healthcare provision, and severe and fatal injuries; highlights the latest reported data released by the Greyhound Board of Great Britain (GBGB) regarding Shawfield Stadium, reporting 197 injuries and 15 deaths between 2017 and 2020; understands that there is no similar data at unlicensed tracks where there is no official regulatory body present to ensure that animal welfare standards are met, and commends campaigners and rescue organisations for their ongoing rehoming and awareness-raising work, including the Scottish SPCA, One Kind, Dogs Trust, Blue Cross, RSPCA, League Against Cruel Sports Scotland, Scotland Against Greyhound Exploitation, and others.

***S6M-06187 Pam Duncan-Glancy: Welcoming the MS Society's Report, Reduced to Breaking Point**—That the Parliament welcomes MS Society's report, *Reduced to Breaking Point*, detailing the impact of the cost of living crisis on people living with MS; notes that the report found there were extra costs associated with living with MS in relation to utilities, transport, treatments and care; recognises that the report found that over a quarter of people with MS do not have enough money for food while one in four could not afford to keep their home warm; understands that, according to the report, the crisis has had an impact on the ability of individuals to manage their MS with 29% reporting that they have stopped or reduced spending on treatments or therapies; notes that the report identified difficulties in accessing flexible, well paid employment for people living with MS and that many found social security benefits payments too small and difficult to access, and believes that the Scottish and UK governments should accept the report's policy recommendations, including calls for further support packages to ameliorate the impact of the cost of living crisis, increase the rate of benefits, and change the eligibility criteria for benefits, such as Adult Disability Payment, to remove the "20-metre rule".

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
