**\*[S6M-06783](#) Paul O'Kane: Carers Rights Day 2022**—That the Parliament recognises that Carers Rights Day 2022 takes place on 24 November 2022; understands that Carers Rights Day is about raising the awareness of the rights that carers have, but also of what carers still lack in rights and representation; notes the view that amplifying the voice of carers has become even more vital; believes that they have been demonstrably impacted by particular pressures, from the COVID-19 pandemic to the rise in the cost of living; notes the view that, as the cost of living crisis continues, carers must be listened to and their concerns taken seriously and acted upon by the Scottish and UK governments; notes that the State of Caring in Scotland 2022 survey, conducted by Carers Scotland, found that 40% of carers on carers allowance are cutting back on food and heat to make ends meet; celebrates what it sees as the immense contribution that carers make, firstly to their own families and loved ones, who they take care of and support, but also to their wider communities, and believes that their efforts, in turn, prevent added pressures being put onto health and social care services.

**\*[S6M-06863](#) Liam McArthur: Orkney RFC and Caithness RFC Inaugural Come Ashore Cup Raises £18,000**—That the Parliament commends Orkney RFC and Caithness RFC for fundraising over £18,000 for two local charities as part of the inaugural "Come Ashore" Cup in memory of Alexander Mill; understands that the over-35s Orkney Vikings and Caithness Evergreens, with support from the Caithness XV, went head-to-head in Thurso on 22 October 2022 in a veterans' game celebrating the life of Alexander Mill, the former Caithness player who died suddenly on his farm in April 2021, and underscoring the importance of mental wellbeing; congratulates the Caithness side, which came out on top against their far north rivals with a final score of 20-5, securing the trophy in the form of a traditional Orkney bridal cog on an engraved Caithness stone base; notes that the cog was presented by Alexander's wife, Norma, to Evergreen's captain, Will Mill, and was followed by a speech from Caithness RFC vice-president, Russell Mill, on the club's message that it's "OK not to be OK"; recognises that the match was attended by more than 600 people and was followed by a grand charity auction for the Royal Scottish Agricultural Benevolent Institution and the John O'Groats Development Trust Playpark Project, which raised an outstanding £12,500; pays tribute to the efforts of all at Caithness RFC in organising what it sees as the pioneering mental wellbeing initiative; believes that the Come Ashore Cup is a fitting legacy to Alexander Mill and will help encourage more men to discuss their mental health, as well as strengthen ties between the two clubs; thanks Scottish Rugby for its support of the inaugural match, and wishes both Caithness RFC and Orkney RFC all the very best for the future.

### Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
